Thompson's PATIO AND PAVING CLEANER

Thompson's Patio And Paving Cleaner is ready to use Water Based Treatment for the effective removal of dirt, mould and algae from patios, paths, concrete and tarmac drives and block paved areas.

INTRODUCTION

Thompson's Patio And Paving Cleaner has been specially formulated to clean patios, paths, block paved areas, drives and similar exterior surfaces to give immediate and effective results. Thompson's Patio And Paving Cleaner kills mould and algae and protects against fungal growth whilst, at the same time, removing dirt.

Thompson's Patio And Paving Cleaner is approved under the Control of Pesticides Regulations 1986. For use as directed. HSE No. 5985.

COMPOSITION

Contains 2% w/w benzalkonium chloride (20g/l) and surface active agents as a solution in water.

PROPERTIES

Appearance - Slightly hazy, low viscosity liquid.
Colour - Colourless.
Odour - Low, inoffensive.

FIELDS OF APPLICATION

Thompson's Patio And Paving Cleaner can be used for cleaning and surface disinfection of patio slabs, paving slabs, flagstones, concrete, tarmac, red brick, tiles, block paving and similar surfaces.

FOR USE ONLY AS A SURFACE BIOCIDES.

PREPARATION

Remove any large accumulations of moss or algae using a stiff brush. Remove any oil, grease or fuel stains using Thompson's Oil and Drive Cleaner. Sweep up any surface debris.

APPLICATION

Thompson's Patio And Paving Cleaner can be applied by brush, low

pressure spray or a watering can fitted with a sprinkler rose. Scrub the surface with a stiff bristle brush and leave for 10-15 minutes. Wash off thoroughly with a brush or alternatively hose down, ensuring that all surface residues are washed away. Refer to 'IMPORTANT NOTES'.

COVERAGE

Thompson's Patio And Paving Cleaner should be applied at the rate of 1 litre per 3-4 m².

CLEANING OF TOOLS

Remove as much product as possible from application equipment before washing.

Clean brushes, sprays or watering cans immediately after use with water.

IMPORTANT NOTES

Surfaces may become slippery during cleaning. Observe reasonable precautions during use. Surfaces that are heavily soiled may not return to a "newly laid" appearance.

Algae or mould will be killed, but may not be completely removed. Allow to weather and brush away after 7 days.

Oil or grease marks may not be totally removed. Use Thompson's Oil & Drive Cleaner.

If Thompson's Patio And Paving Cleaner comes into contact with surrounding grass or plants, rinse thoroughly with water.

STORAGE

Observe label precautions. Store between 5 and 25°C. Keep in a cool, dry, well ventilated place away from sources of heat, ignition and direct sunlight. No smoking. Containers which are opened should be properly resealed and kept upright to prevent leakage. The material and its container must be disposed of in a

safe way. Keep in a safe place away from children.

To avoid risk of spillage always store and transport in a secure and upright position.
